## How to donate :

- Set up a standing order or single payment through your bank.

- Go to ParentPay, find the item "School Funds" and make your payment in the normal way
- Pop your cash or cheque (made payable to Parkstone Grammar School Subs Account) in an envelope and ask your daughter to take it to the Finance Dept at the school

## Boost your donation with Gift Aid

Gift Aiding your donation will boost it by 25p for every £1 you donate!

Gift Aid is reclaimed by the charity from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.
